The said (student) Sri/Smti _____ hereby agree to His her own free will and consent and with the approbation and consents of the said (surety) _____ testifies by execution by him of this presents, agree with and to the Govt. of Assam and his successors in office and sign that the said (Student) Sri/Smti _____ shall well and faithfully undertake his/her training in (subject) _____ of the (institute) _____ Where he/she has been awarded a scholarship by the Govt. of Assam.

2. The said (student) Sri/Smti _____ shall return To Assam within a month of completion of his/her training _____

3. The said (student) Sri/Smti _____ while undergoing his/her training in the said institution _____ shall abide by the ruler or orders laid down or given by the authorities of the institution for the conduct of its students and shall complete his/her training to the satisfaction of the authorities of the institution and to that of the Govt. of Assam.

4. The said (student) _____ shall after completing His/her training at said institution and if as required by the said State Govt. serves the Governor of Assam has successors in office and assigns in the State of Assam for the 5 (five) years and shall during the whole of such period diligently and efficiently do all at and discharged all duties which may be required to be done by him/her as a Government Office and shall observed the rules for the times be in force made by Govt. regulating the conduct of its servants.

5. Should the Government of Assam not require the service of the above student on his/her completion of the training than the above student shall _____

Assam for a minimum period of 5 (five) years and he shall have to offer the services in the Industrial concern, if required to do so or take up other compliable employment indicated by the Govt. of Assam for the same period duties which the above student shall be at the disposal of the Industrial concern.

The obligations under this shall cause only if the State Govt. do not require his/her Service.

6. The Government of Assam shall pay the said (student) _____
_____ During the period of his/her stay at the institution a stipend of
Rs. _____ (Rupees _____) only.

7. The said (student) _____ of the said (surety)
Shall have to refund to the Govt. of Assam his/her successor in office and assigns. The total amount of the expenditure incurred of his/her training while at the said institution by Government of Assam in the event of negligence of his conduct, refusal to take up service under the Govt. of Assam or under the industrial concern indicated by the Govt. of Assam when offered or leaving it before the expiry (five) years or while in service break of the conditions herein above convened of the part of the said (student).
